# Our Active Product Certification List



**Global Recycled Standard (GRS)**  
set the criteria for third-party certification of recycled materials and chain of custody. The GRS includes a higher (20%) minimum recycled content percentage and additional social and environmental requirements related to processing and chemical use.



## Steps to Certification



**The Organic Content Standard (OCS)**  
aims to increase organic agricultural production. OCS is a voluntary global standard that sets the criteria for third-party certification of organic materials and chain of custody.



**The Recycled Claim Standard (RCS)**  
are designed to boost the use of recycled materials. RCS set the criteria for third-party certification of recycled materials and chain of custody.



**The Responsible Wool Standard (RWS)**  
aims to improve the welfare of sheep and the land they graze on. RWS requires all sites, from wool farmers to the seller in the final business-to-business transaction, to be certified. RWS farmers and ranchers must meet animal welfare, land management, and social requirements.



**The Responsible Mohair Standard (RMS)**  
addresses animal welfare and environmental responsibility in mohair supply chains. RMS is a voluntary standard that requires all sites, from farms through to the seller in the final business-to-business transaction, to be certified. RMS farmers and ranchers must meet animal welfare, land management, and social requirements.



**The Responsible Alpaca Standard (RAS)**  
safeguards the welfare of alpacas and the ecosystems around them. RAS is a voluntary standard that requires all sites, from alpaca farms through to the seller in the final business-to-business transaction, to be certified.



**The Responsible Down Standard (RDS)**  
aims to protect ducks and geese used for down. RDS incentivizes the down and feather industry to treat ducks and geese humanely and rewards organizations leading the way. The standard also gives companies and consumers a way to know what's in the products they buy.

## OCEAN Bound Plastic Certification

OBP is an "Abandoned Plastic Waste" (microplastics, mezzo-plastics and macro-plastics), located within 50km from shores where waste management is inexistent or inefficient. When already located in a landfill or managed dump site, the plastic waste is not considered as OBP. However, when abandoned in an uncontrolled or informal dump site, this waste is considered as OBP.

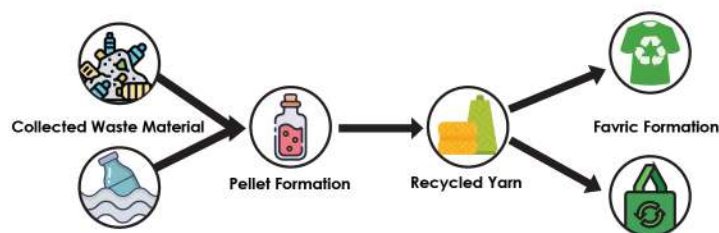

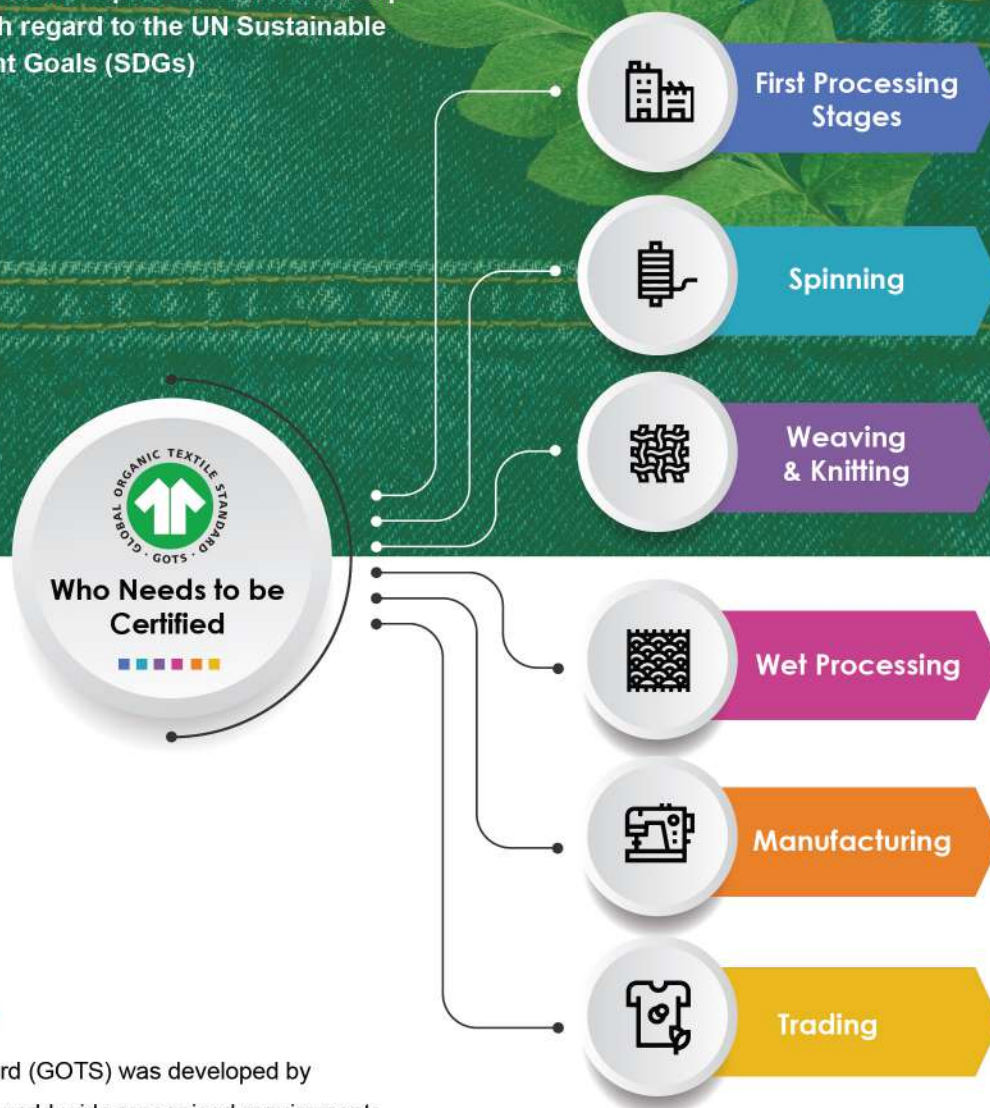

At first, GOTS certified textile products must need to contain a minimum percentage of 70% Organic natural fibers.



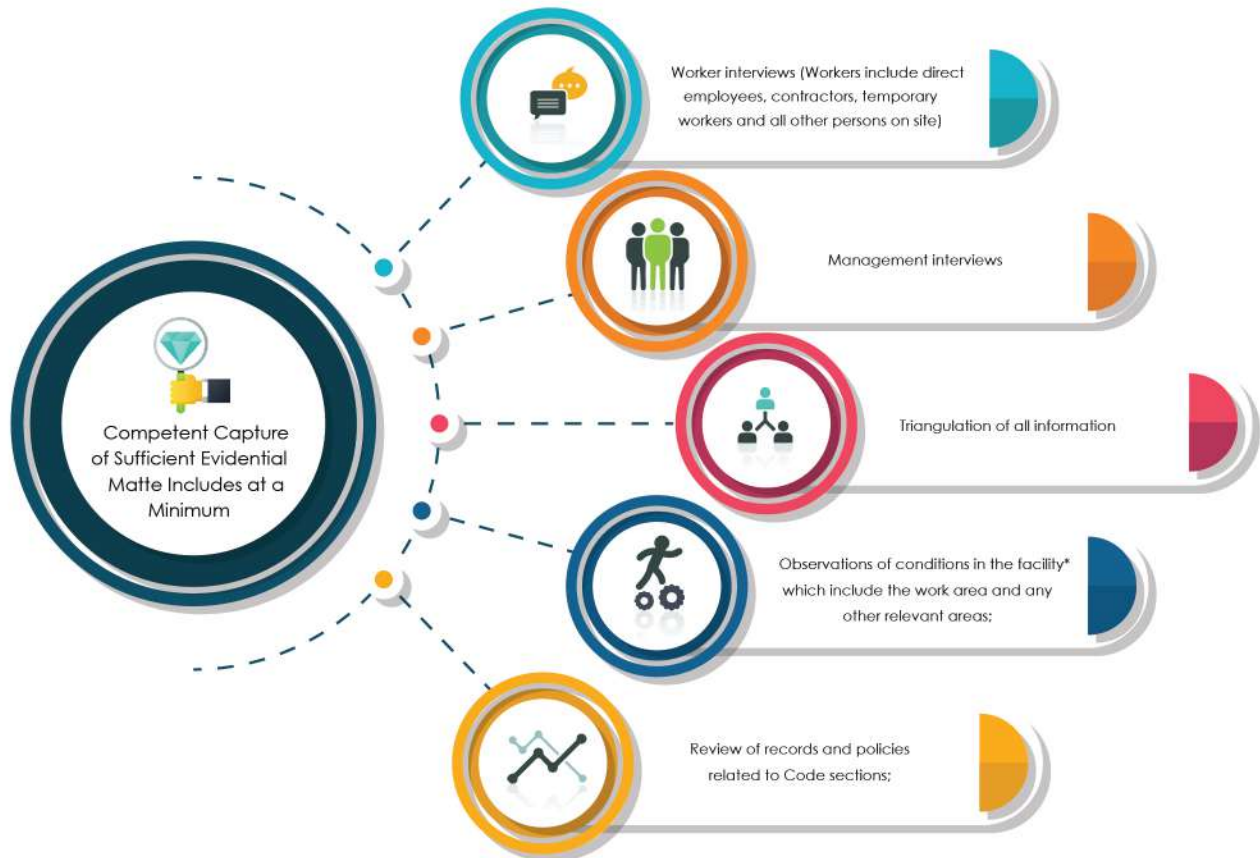

Association of Professional Social Compliance Auditors (APSCA) is an industry association, whose members represent a substantial majority of the Social Compliance audit industry. As the leading industry association, APSCA exist to enhance the professionalism, consistency and credibility of the individuals and organizations performing independent social compliance audits. APSCA is the professional body for the social compliance industry and is standard agnostic. While there are other organizations, APSCA is the only one that crosses all types of social compliance audits and is not tied to a specific audit program.



## GSCS & APSCA

GSCS International is an APSCA full member firm with a group of Certified Social Compliance Auditor to ensure that appropriate time spent on site to competently achieve sufficient evidential matter. Appropriate time is a function of man factors, including but not limited to the number of workers and physical size of the facility. Industry standard practice indicates that effective consideration would generally require a minimum of one auditor day on site for small facilities (e.g. less than 100 workers), whereas for larger facilities with more workers, two or more auditor days will be required, incrementally, based on the number of workers and the physical size of the facility.

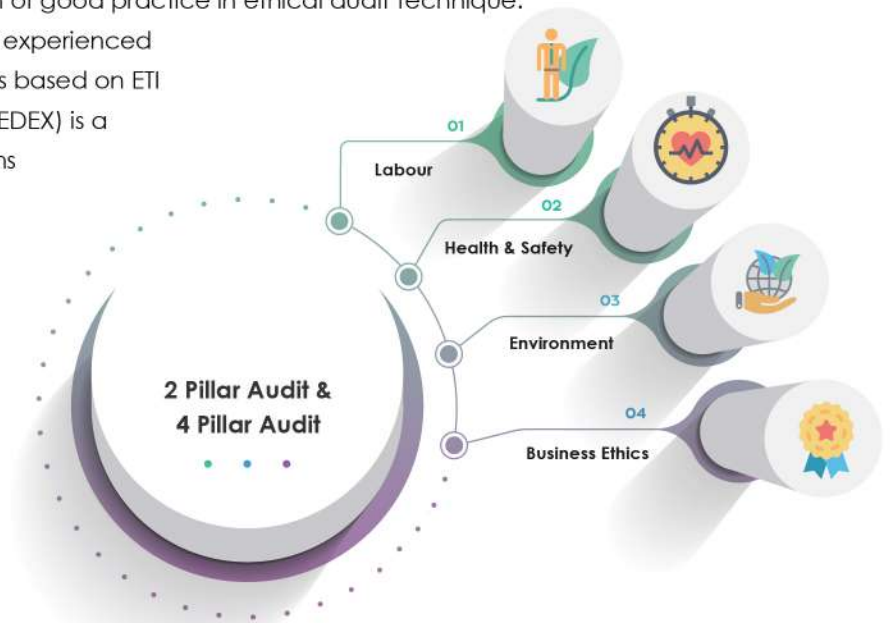


## SMETA & SEDEX

SMETA is an audit procedure which is a compilation of good practice in ethical audit technique. The SMETA documents are designed to be used by experienced auditors in line with current established practices. It's based on ETI based code. The Supplier Ethical Data Exchange (SEDEX) is a web-based system designed to help organizations manage data on labor practices in their supply chain.

## Pillars of SMETA Audit

A SMETA 2-Pillar audit comprises the 2-Pillar of Labour Standards and Health & Safety. A SMETA 4-Pillar audit includes all the above elements; plus the additional pillars of Environment (extended assessment replaces shortened assessment) and Business Ethics.

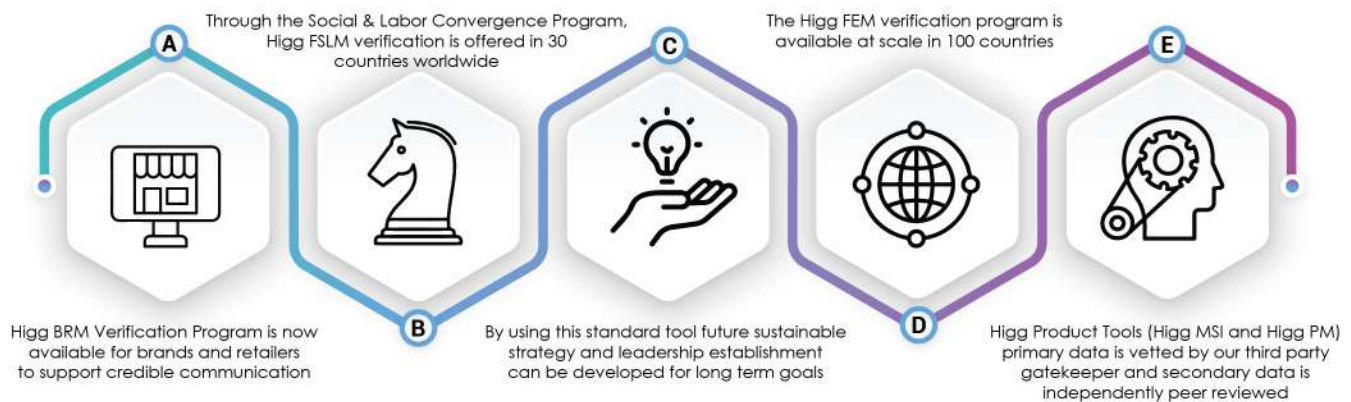


## SOCIAL & LABOR CONVERGENCE

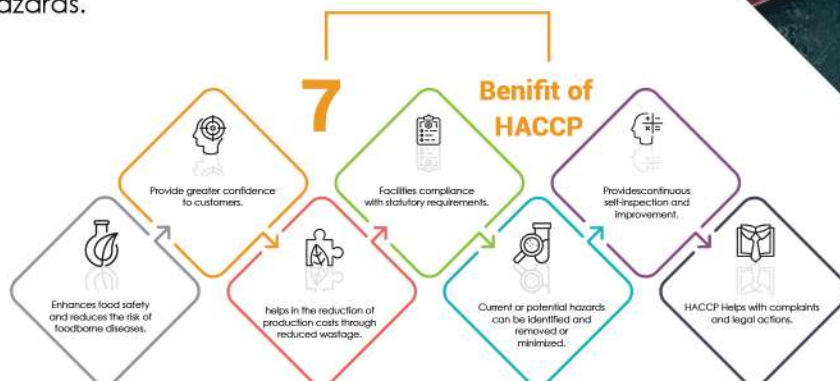

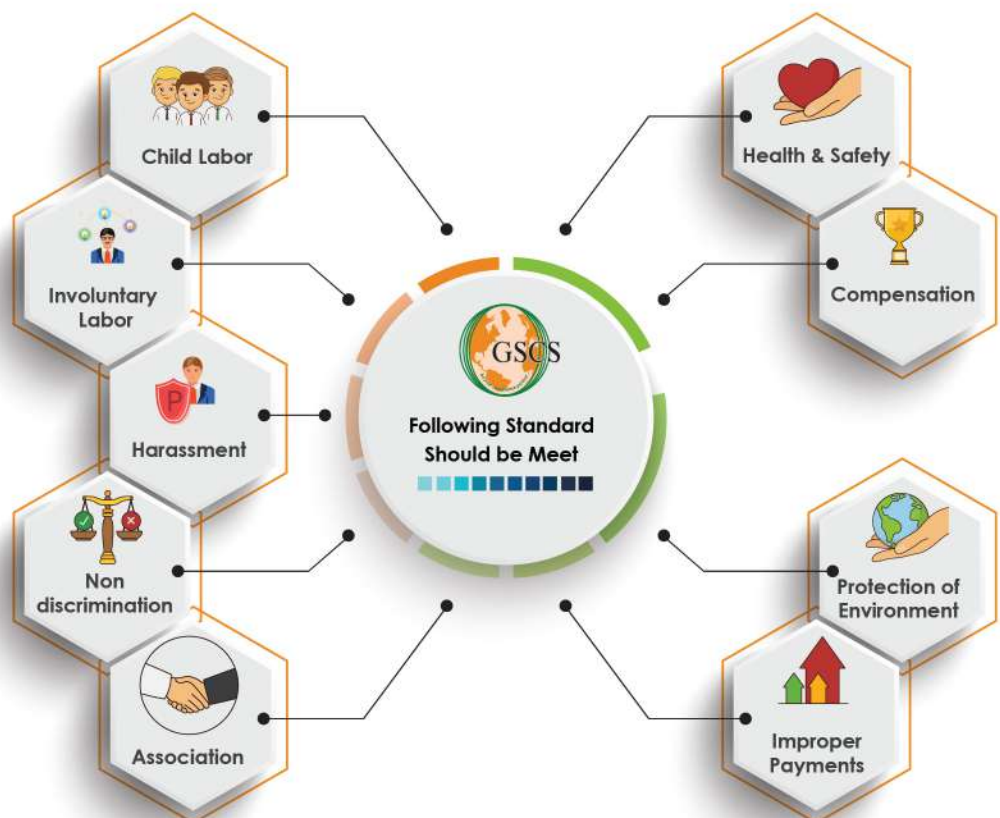
ZDHC InCheck Verification Level 1 helps to create a traceable chemical inventory in order to lessen the impact of harsh & hazardous chemical on environment.

This verification gets the suppliers' check mark on the ZDHC Gateway indicating that a supplier has obtained a Verified InCheck – Level 1. The process does not generate a report, but the check mark confirms the results from the review are at least 80%.

## 100% Inspection for Luxury Brands

On basis of our customer's need we also provide 100% inspection services. This type of inspection is carried out on 100% packed goods. Factory should arrange totally separate unpacking or packing and inspection area. Our quality inspectors are professional to check and quarantine acceptable and unacceptable goods on basis of customer's quality level, separating repairable/non-repairable goods follow up the disposal of non-repairable and rejected goods, seal the cartons onsite with our security gum tape so there is no risk of mixing up, follow up shipment loading.



## Final Random Inspection (FRI)

Our inspectors pull a random sample of finished and packed goods, based on internationally recognized statistical random sampling technique (AQL).

Quantity/Workmanship Styling, color, functions, packaging, size specification etc. are verified to ensure the required product specifications are met. The goods should be at least 80% in packed and balance goods should be under finishing process. None of the goods should be in sewing or cutting section. GSCS follows customer requirement. In case, where not set up requirement is provided by customer, GSCS follows generic criteria.

## Product Quality Control & Inspection

GSCS provides quality assurance services in Bangladesh, Myanmar and Ethiopia for variety of customers covering incoming control or Material Inspection, Pre-production control (On site size set checking and PP meeting), Sample picking Layout and First output quality checking In line Inspection (DP) and Final Random Inspection (FRI). Our quality engineers are having 10 to 15 years inspection and Quality controlling experience in 3rd party, buying once and multi-national factories.



## Incoming Inspection

In the incoming inspection we verify that the factory received correct material according to the agreed standard by customer. Fabric inspections by 4-point system to ensure that there is no such defects which can hamper the production on line or be accountable to produce products that is below standard. Accessories inspections are carried out on the basis of Acceptable Quality Level (AQL) to ensure the accessories quality is correct.
